MICROSOFT LICENSE STATEMENT

TERMS AND CONDITIONS REGARDING USE OF MICROSOFT

SOFTWARE October 10, 2011, This document concerns the use of Microsoft software, which includes computer software provided to you by Northland Communications as described below, and may include associated media, printed materials, and “online” or electronic documentation (individually and collectively “SOFTWARE PRODUCTS”). Northland does not own the SOFTWARE PRODUCTS and the use thereof is subject to certain rights and limitations which Northland needs to inform you. Your right to use the SOFTWARE PRODUCTS is subject to your agreement with Northland, and to your understanding of, compliance with, and consent to the following terms and conditions, which Northland does not have the authority to vary, alter or amend.

Definitions “Client Software” means software that allows a Device to access or utilize the services or functionality provided by the Server Software. “Device” means each of a computer, workstation, terminal, handheld PC, pager, telephone, personal digital assistant, “smartphone,” or other electronic devices. “Server Software” means software that provides services or functionality on a computer acting as a server. “Redistribution Software” is the software described in Paragraph 4 (Use of Redistribution Software”) below.

Ownership of Software Products The SOFTWARE PRODUCTS are licensed to Northland from an affiliate of the Microsoft Corporation (“Microsoft”). All title and intellectual property rights in and to the SOFTWARE PRODUCTS (and the constituent elements thereof, including

but not limited to images, photographs, animations, video, audio, music, text and “applets” incorporated into the SOFTWARE PRODUCTS) are owned by Microsoft or its suppliers. The Licensed Products are protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Your possession, access, or use of the SOFTWARE PRODUCTS does not transfer any ownership of the SOFTWARE PRODUCTS or any intellectual property rights to you.

Use of Client Software You may use the Client Software installed on your Devices by Northland only in accordance with the instructions, and only in connection with the services, provided to you by Northland.

YOU MAY NOT USE, MODIFY, COPY, AND/OR DISTRIBUTE ANY REDISTRIBUTION SOFTWARE UNLESS YOU EXPRESSLY AGREE TO AND COMPLY WITH SERVICES PROVIDER USE RIGHTS (“SPUR”) APPLICABLE TO NORTHLAND, WHICH TERMS MUST BE PROVIDED TO YOU BY NORTHLAND. Microsoft does not permit you to use any Redistribution Software unless you expressly agree to and comply with such additional terms, as provided to you by Northland.

Copies You may not make any copies of the SOFTWARE PRODUCTS; provided, however, that you may (a) make one (1) copy of Client Software on your device as expressly authorized by Northland; and (b) you may make copies of certain Redistribution Software in accordance

You must erase or destroy all such Client Software and/or Redistribution Software upon termination or cancellation of your agreement with Northland or upon transfer of your Device to another person or entity, whichever occurs first.
